#### Meet Beth Johnson, Novato Chief of Police

The membership was pleased to meet the new Chief of Police and asked questions about issues impacting Downtown. Primarily the questions related to concerns about the homeless population sleeping in doorways and the growing impacts on businesses. The question was posed about having a "beat cop" who is a constant presence in downtown to deter and address certain behaviors. There was discussion about mental health services available and the challenge of service resistant individuals.

- <u>City of Novato Update</u> Jessica Deakyne Discussed the Single Use Ordinance on the horizon. The City is still working with the County to finalize details.
- New Economic Development Analyst has been hired. Sullina Sanchez will be starting next week.
- The audit of the BID list and classifications is almost complete.
- The Tenant Improvement Grant Application date has not been set yet but will hopefully be open by the end of the year.
