- Local Kitchen's has opened in the location previously holding Chipotle.

- The planter project is in full force. There have been challenges with the City getting all the irrigation worked out. We don't plan to plant until those issues are solved. Plant designs are completed - 3 designs alternating the length of Grant. 2 variations for planters getting shade & sun.
- Stephanie will have a meeting with the City on Thursday to review the audit of the BID membership list.

- Additional discussion about the concerns related to the "roaming vendors"

- Traci Prado has sold The Village Restaurant to two of her chefs. There should be no change in the concept just ownership change. Her family moved to Sacramento. She and her husband will still own the building and the adjacent office building.
- Addressed social media rumors that Henhouse is not coming to Novato. They are hoping for a late spring or early summer opening. And construction is underway.

- New Businesses: Vildblum; Matt's Board Shop; and Local Kitchens

- February BID Advisory Board meeting with address the Housing Element proposed in Downtown.

- We're hoping to start a reusable aluminum cup program at events – if we can find additional sponsorship to offset the cost.

Other Business + Open Discussion
