Everyone at the meeting shared some good things that are happening at their business.

First Fridays Update

Stephanie asked for an update on the creation of a merchant led committee to organize and program First Fridays. Meghan said she had spoken with Emily of Village Child but has not yet formulated a plan. The decision needs to be made by April so there can be proper marketing of the event.

Farmer's Market Relocation Update & Discussion

- Steve Jordan gave an update on the meeting held with him, Barbara, Stephanie, the City Manager, Assistant City Manager and Sullina Smith. Representatives didn't feel good about the progress that was made in the meeting. It was clear at that point the City had no intention of making substantive changes to the plans – even after hearing our concerns. Stephanie was in the process of following up with Council member Tim O'Connor to see if any additional progress could be made.

- There was an impassioned discussion on the issue. Feedback from members in the room was as follows:

- Biz 1: Historically people shopping at the Farmer's Market do not shop at stores. They get their items, eat food at the market and go home.

- Biz 2: Suggestions to have the Farmer's Market held at the Square Shopping Center or in the parking lot of the former Pini Hardware building at 1st & Grant.

- Biz 3: It is troubling that the DNBA has historically been intimately involved in the decisions surrounding the Farmers' Market from negotiations to signing the MOU.

- Biz 4: It's hard to measure the positive impact of the market because they may see a store that night and come back.
- Biz 5: The lack of inclusion is the biggest issue.

BID Advisory Board Meeting Update - Steve Jordan, Chair

- Clare Hartman the new Community Development Director came to speak about her visons for the departments, including changes to the permitting and planning departments. She was very well received and the members were hopeful about her plans.

- He reported on the second "snafu" with the business license renewal process for BID members leading to more incorrect charges.
