Tell Us What Is Important To You In 2025

This was a lengthy and productive conversation. The following are expressed priorities:

- Economic Development. Businesses want the City to be more proactive in recruiting and retaining small business not just focusing on Vintage Oaks.
- The City needs to make it easier to open a business in Novato. Several examples were sited where a business planned to come to Novato but the process was so arduous they opened in San Rafael or Petaluma instead.
- Partnership opportunities with Chamber and DNBA were discussed.
- The City needs to invest marketing efforts and dollars into attracting businesses to Novato.
- City needs to outreach to existing businesses and start repairing relationships. Many existing business owners speak negatively about Novato because there has been no relationship developed with the economic development department in more than 7 years.
- Recruit associate members to the BID.
- Can Council/City Staff address the long-term vacancies like the former Albor Medical, Ken's Kitchens and Copperfield's Books corner spaces through a derelict building ordinance? Perhaps offer incentives to building owners. This is a huge concern with members. Membership feels this is leading to the opinion that Downtown is dying. They are seeing it in their sales.
